

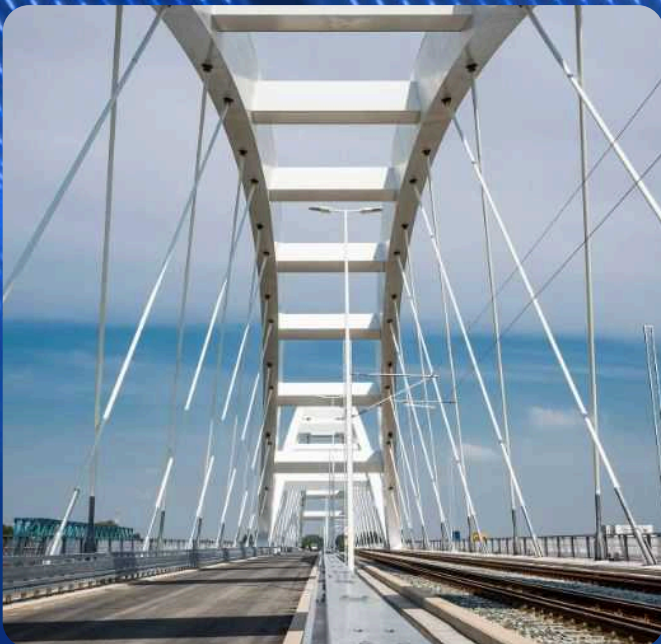

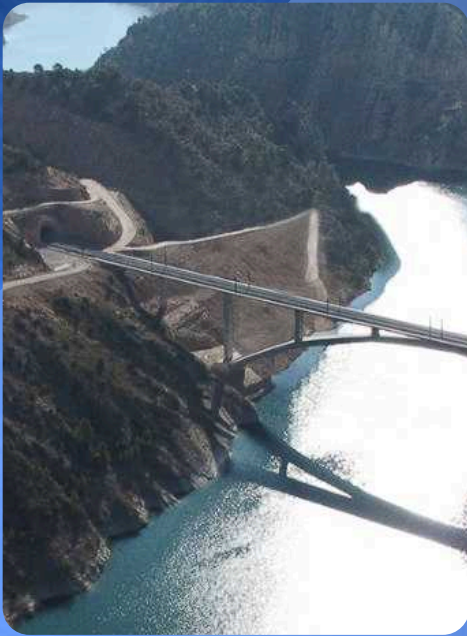

The group has a solid track record of over 100 years in the following sectors and divisions:



The path to success

In the process of searching for the best tool to provide that added boost of productivity and efficiency, Grupo Azvi undertook:

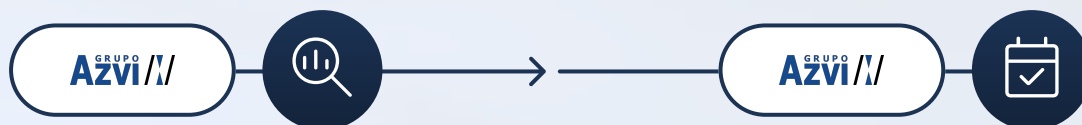
A market research to find it; **during this search, they came across Bigle through its social media and events that Bigle regularly organises.** At one of these events, Libra, their artificial intelligence tool, was presented. From that moment, Azvi Group requested a meeting and a tailored presentation of the solution, during which they had the opportunity to interact with it to assess its usefulness for their Legal Advisory department.

The process of integrating Libra was very straightforward, requiring only a brief **training for the Legal Advisory team.** Its simplicity lies particularly in the fact that, **on one hand, Libra is very intuitive and easy to use,** and on the other, it does not require any integration with the company's systems, *allowing it to be operational from the very moment of its contracting and activation.*

During the training conducted by Azvi Group, they worked on **prompts** (instructions given to the tool to interact with it), which were tailored and detailed **to guide the proper use of Libra from the very beginning towards the desired outcome.** To support this, **Bigle also provided an executive guide on legal prompting,** which proved helpful for those less familiar with this type of artificial intelligence.

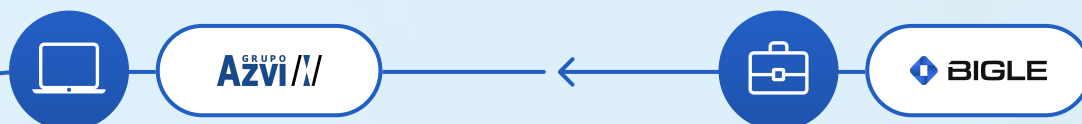

Results

Grupo Azvi highlights that Libra is an excellent analysis tool, and for that reason, they rely on it in two main ways:

- **On one hand**, they request risk and weakness analyses of documents, asking for contractual solutions and alternatives.
- **And on the other hand**, by directly requesting the creation of contractual frameworks or standalone clauses, which the Group's lawyers then refine and adapt to each specific case.

Additionally, the results and benefits that Grupo Azvi highlights from using Libra are:



Review:

Libra assists in the review of various types of contracts and alerts users to those requiring attention at specific times, such as key dates, deadlines, etc.



It helps prevent legal risks or consequences that are not immediately obvious:

The fact that it can highlight one or two potential negative outcomes of a clause – which may be difficult to foresee given the time constraints typically involved in contract analysis – already makes it a very valuable support tool.



Time savings:

Grupo Azvi is now able to handle more projects with the same number of lawyers, which also increases their effectiveness. Prior to using the tool, they often faced time pressures and tight deadlines to finalise contracts.

Azvi Grupo's Legal Advisory department has integrated new technologies into its processes, as is the case with Libra. Other technical and engineering departments are also doing so, **supported and guided by a dedicated R&D and Digital Transformation department. This positions the Group as a company that incorporates technology into its corporate strategy** and, as such, innovation is a core pillar of its identity – one that drives its leadership in the civil engineering sector.
